Word from the President

Dear Sir / Madam

25 years ago, A. Mongon, F. Dittmar, H. Budde, I. Blakey, M. Gibbons, L. Priori and others decided to create IFIEC Europe. Their objective was to defend the competitiveness of energy-intensive industries and in particular gas and electricity consumers for which energy is a key factor of industrial competitiveness.

Where do we stand now? It was clearly stated by DG Energy in January that "European industry does suffer from an important disadvantage in total energy and climate costs in comparison with competing regions of the world." And the gap with other competing regions of the world may have never been so important: prices are 3 times higher in Europe than in the US for natural gas, and 2 times higher for electricity. And according to the IEA the situation could worsen for 2 decades more.

Would these disparities last, the consequences for the European manufacturing industry - which represents 30 million direct jobs in Europe - would be dramatic: energy intensive industry is a price taker and can't pass on additional costs to its - mainly global - customers. Hence the need for urgent and structural measures.

Fortunately, as once said by Bertold Brecht, "when the need at the highest, the solution at the nearest". And the solutions do exist: we highlighted them in our *Manifesto* issued ahead of the March EU Council. Thanks to the *unprecedented support received by IFIEC's members* (at that time already, over 150 signatures by CEOs representing companies from 23 different countries, more than 1.2 million direct jobs and a cumulated turnover exceeding EUR 400 bn), it did have an impact on the conclusions of the Council:

- "- Industrial competitiveness concerns should be systematically mainstreamed across all EU policy areas and be part of impact assessments...
- A coherent European climate & energy policy... addressing the issue of high energy costs, in particular for energy-intensive industries."

25 years after its birth, IFIEC Europe still has a major role to play and a key objective to reach "competitive energy for industry". This is the main focus of this Energy Forum 2014 which never attracted so many participants. I do hope that you will enjoy it and that, with your support, we'll all be able to reindustrialize Europe.
